Church Representation Rules: Wimbledon Team

1 New Church Representation Rules: With effect from 1 January 2020, the Church of England has brought into force new church representation rules that govern how PCC and District church councils operate.

2 Rules for parish governance: Part 2 of the rules state that the default position is that the Model Rules set out in Part 9 apply to each parish

The introduction to the rules does say that one of the aims of the 'Simplification Task Group' of the Archbishops' Council that drafted these new rules was that parishes should be given much greater flexibility over their constitutional arrangements so that they could operate in the way that was most effective for the mission, life and work of the local church.

3 Modification of default rules: The default rules for parish governance can be modified. There are certain rules that cannot be varied such as the number of laity on the PCC must outnumber clergy.

4 Reason and timeline for proposing to seek approval of scheme modifying Part 9 of the Church Representation Rules:

The coming in to force of the new Church Representation Rules gives an opportunity to build on the Part 9 rules in a way that will help the Wimbledon Team look to the future, recognising the valued diversity within the parish in each of the four churches.

5 Annual review

This document will be reviewed by the PCC once a year. Any amendments can be proposed by the PCC but amendments to be approved by the next APM].

Note: Churchwardens Measure 2001: section 3 states that (unless the church meeting has decided otherwise) a churchwarden should have two years out of office after serving for six years.
